The selection committee constituted under the provisions of section 46(3) of the Real Estate (Regulation and Development) Act, 2016 invites applications from the eligible candidates for the appointment of **One whole time Member (Judicial)** of the Real Estate Appellate Tribunal, Punjab.

The notice was given regarding inviting of applications for the post of One whole time Member (Judicial) of the Real Estate Appellate Tribunal, Punjab, in which last date to submit the application was 19.08.2025. In the meeting of Hon'ble Selection Committee held on dated 19.01.2026 it is decided to give one more opportunity to all eligible candidates to apply for the above said post.

The candidate should have held a judicial office in the territory of India for at least fifteen years or has been a member of the Indian Legal Service and has held the post of Additional Secretary of that service or any equivalent post, or has been an advocate for at least twenty years with experience in dealing with real estate matters

The Member shall hold office for a term not exceeding five years from the date on which they enter upon their office, or until they attain the age of sixty-five years, whichever is earlier and shall not be eligible for re-appointment

Other terms and conditions shall be as per the Punjab State Real Estate (Regulation and Development) Rules, 2017 and notifications and guidelines issued by Government from time to time.

Candidates are requested to submit their application in the prescribed format along with documents for the post applied for. Application form is available at pbhousing.gov.in and rera.punjab.gov.in.

Candidates who have applied before 19.08.2025 do not require to apply afresh for this post, however the applicants who have applied after 5.00 P.M. on 19.08.2025 are required to apply afresh alongwith complete biodata/profile and qualification for the post applied for.
