The present appeal has been filed with an enormous delay of more than 1000 days (1067 days). The impugned order was passed in July 2020 and thereafter the respondents (allottees) were in execution, which proceedings were also contested by the appellant. Before us it has been conceded that some amount had been paid by the appellant in execution of the impugned order.

If that be so then it is abundantly clear that the appellant was in the know of the proceedings and hence cannot offer any justification for such an enormous delay. We have perused the application and find the assertions made therein to be uninspiring and insufficient to persuade us to interfere in the wake of the delay in approaching the Court. Dismissed on the issue of delay. Since the appeal has been dismissed the amount deposited by the appellant by way of compliance under Section 43(5) of the Act, be released to the respondent along with interest that may have accrued thereon.
