
Present: Ms. Surinder Chopra complainant in person

The representative for the respondent has appeared and filed memo of appearance on behalf of the respondent. He seeks time to file power of attorney and written reply to the complaint. The office report shows that the respondent was served through email on 11.06.2019 and through RC on 26.06.2019 and written reply was required to be filed within fifteen days from the date of service.
