

Ms. Khushboo Arora representative for the respondent.


Ms. Khushboo Arora appeared for respondent and filed memo of appearance on behalf of the respondent. The same is taken on record.

 The parties have stated that the matter has been amicably settled. Ms. Durga Devi complainant has suffered a statement that a compromise has been effected between the parties and matter has been settled for a total sum of Rs.08,21,702/- as full and final settlement and the respondent has issued 03 cheques in her favour. In these circumstances, she withdraws this complaint at this stage reserving her right to revive or file a fresh complaint on the same cause of action in case any of the cheque is dishonoured. The complaint may be disposed of as withdrawn having compromised.

Durga Devi Vs. Maya Garden Magnesia

On the other hand, Ms. Khushboo Arora, representative for the respondent has suffered a statement to the effect that a compromise has been effected between the parties and matter has been settled for a total sum of Rs. 08,21,702/- as full and final settlement and the respondent has issued 03 cheques in favour of the complainant. The matter may be disposed of accordingly.

In view of above statements of parties, the complaint is accordingly disposed of as withdrawn having compromised with liberty to the complainant to revive or file a fresh complaint on the same cause of action in case any of the cheque is dishonoured.
