The project area of 125 acres, wherever so appearing in the Development Management Agreement dated 17<sup>th</sup> day of October 2017, henceforth be read as 161 acres in view of the agreement signed between the Company and the Governor of Punjab through The Chief Administrator, Punjab Urban Development Authority (PUDA) dated 15th July, 2019.
- 3. Clause No. 8 is added to Point 3- "CONSIDERATION AND OTHER RIGHTS AND OBLIGATIONS" to the Development Management Contract dated 17<sup>th</sup> October, 2017 to read as under:
  - "Aeropolis Infrastructure Private Limited shall pay Sukhm Infrastructures Private limited a sum of Rs. 3.00 Cr. (Rupees Three Crores Only), to be paid in 4 equal instalments at the end of the each Financial year. The first instalment shall be payable in the Month of March 2020. Further acknowledged that AIPL has paid certain amounts to Income Tax Department, which were due on part of SIPL; and all such considerations shall be considered as part of the consideration payable by AIPL to SIPL".
- 4. All the other terms and conditions of the Development Management Contract dated 17th day of October 2017, shall remain the same and binding on both the parties to this ADDENDUM.
