Sir,

I am directed to refer to your application dated 16.05.2012 on the above subject and to say that Air HQ has no objection for construction of 44.20 meters high IT integrated mega township project at Sector-66A, Mohali, Punjab by M/s Sukhm Infrastructures Pvt Ltd, subject to the following conditions:-

- a) The vertical extent (highest point) of the buildings shall not exceed 44.20 meters above ground level/ 349.20 meters above mean sea level.
- b) Standard obstruction lightings to be provided by the company. The lights shall be switched 'ON' during night and poor visibility. Provision shall be made for standby power supply to the light to keep them 'ON' during power failure.
