This is in reference to your application for Grant of EC under the provision of the EIA Notification 2006-regarding in respect of project Commercial Project namely "Cyber Square" at Site no. 01 & 02, Phase -IX, Focal Point, Distt. S.A.S. Nagar, Mohali, Punjab by M/s CEE DEE Developers Private Limited submitted to SEIAA, Punjab vide proposal number SIA/PB/INFRA2/496843/2024 dated 16/09/2024.

3) State Environment Impact Assessment Authority (SEIAA), Punjab has examined the proposal for Commercial Project namely "Cyber Square" located at site no. 01 & 02, Phase-IX, Focal Point, Distt. S.A.S. Nagar, Punjab by M/s CEE DEE Developers Private Limited, for total land area @ 10,117.50 sqm. and built-up area of 58,395.91 sqm. The project is covered under category 8(a) of the schedule appended with the EIA Notification dated 14.09.2006 and its subsequent

amendments and requires appraisal at the State Level.

4) The proposal has been appraised as per the procedure prescribed under the provisions of EIA Notification 14.09.2006 based on mandatory documents enclosed with the online application viz Form-1, Environment Management Plan (EMP), approved layout plan, and additional documents and subsequent presentation /clarifications made by the project proponent and his consultant to the observations of State Environment Impact Assessment Authority (SEIAA) and State Expert Appraisal Committee (SEAC).

11. Rainwater recharging detail
One rain water holding tank of 175 KL capacity has been proposed in the project considering 2 days storage.

12. Solid waste generation and its disposal
a) 836 Kg/day:
b) Biodegradable waste will be composted by use of Mechanized Composter having capacity 1 x 450 kg/day for processing of wet waste including horticulture waste.
c) Recyclable waste (paper, plastic wood, cardboard, metal, glass, rubber etc.) sent to authorized recycler for recycling.
d) Non-biodegradable waste (recyclable waste) will be disposed of through authorized recycler vendors.
e) Inert waste will be sent to sanitary landfill site for final disposal at own cost. While, domestic hazardous waste will be handed over to authorized vendors approved by PPCB.
f) The Solid waste shall be managed as per the SWM Rules, 2016.

13. Hazardous Waste & E-waste
Hazardous Waste will be managed & disposed of through authorized vendors as per the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 and E-Waste shall be managed and disposed of as per E-Waste (Management) Rules 2022 and amendments thereof.
The items covered under the schedule appended to the E-Waste Management Rules, 2022 will be collected, stored and disposed of as per the provisions of said rules. The E-Waste will only be given to the authorized recycler/dismantling facility.

14. Energy Requirements & Saving
a) Total power load proposed is 3914 KVA from PSPCL.
b) 3 DG sets i.e., 2 x 1500 KVA, & 1 x 750 KVA set will be installed equipped with canopy and adequate stack height. DG Set will be provided with acoustic enclosure to

minimize noise generation and adequate stack height for proper dispersion.

c) Solar panels have been proposed on the roof top of the building which will generate 53 KW of power generation.

d) Use of LED lamps shall be encouraged in common areas.

Energy Saving:

a) Total Energy Saved: 76.92 KW

6) As per the undertaking submitted by the project proponent, to the effect that no land covered under the Forest Conservation Act, 1980, is involved in the project and no wildlife area covered under the Wildlife (Protection) Act, 1972 is involved in the project. Further, no litigation is pending in respect of the land on which the project is to be developed.

7) The SEAC, constituted under the provision of the EIA Notification, 2006 and comprising of expert members/domain experts in various fields, has examined the proposal submitted by the project proponent in the desired form along with the EMP report prepared and submitted by the consultant accredited by the Quality Council of India (QCI)/ National Accreditation Board for Education and Training (NABET) on behalf of the project proponent in its 309th meeting held on 20.02.2025.

8) The committee after detailed deliberations, decided to forward the case to SEIAA with the recommendation to grant Environmental Clearance for setting up of Commercial Project namely Cyber Square at Site no. 01 and 02, Phase IX, Focal Point, SAS Nagar in land area of 10117.5 sqm and built-up area of 58395.91 sqm subject to the special & standard conditions.

9) The case was considered by SEIAA in its 311th meeting held on 25.03.2025 and 319th meeting held on 18.09.2025, wherein SEIAA observed that the case stands recommended by SEAC. After detailed deliberations, SEIAA decided to accept the recommendations of SEAC and to grant Environmental Clearance to Commercial Project namely "Cyber Square" by M/s CEE DEE Developers, located at Site no. 01 & 02, Phase-IX, Focal Point, Distt. SAS Nagar, Punjab for the total site area of 10,117.50 sqm having built-up area of 58,395.91 sqm, subject to the standard and special conditions as proposed by SEAC and additional / amended conditions.

10) Accordingly, SEIAA, Punjab hereby accords Environmental Clearance to the aforesaid project under the provisions of EIA Notification dated 14.09.2006 and its subsequent amendments subject to proposed measures and strict compliance with terms and conditions as per Annexure-1.

11) The SEIAA reserves the right to stipulate additional conditions if found necessary at subsequent stages and the project proponent shall implement all the said conditions in a time-bound manner. SEIAA may revoke or suspend the environmental clearance if the implementation of any of the above conditions is not found to be satisfactory.

12) Any appeal against this environmental clearance shall lie with the National Green Tribunal, if preferred, within 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

13) This issues as per the decision taken by the Competent Authority.

1.1	The project proponent shall remain responsible for compliance of all conditions stipulated in the Environmental Clearance and adherence to applicable environmental laws until the Environmental Clearance is transferred in the name of the transferee or the resident welfare association, as applicable. In such case both the parties shall approach the SEIAA with joint consent for transfer of Environmental Clearance
1.2	The plantation of saplings shall be carried out in the green belt area as a part of the tree plantation campaign “Ek Ped Ma Ke Naam” and the detail of the same shall be uploaded in the MeriLiFE Portal (https://merilife.nic.in) as an assurance to the MoEF&CC Office Memorandum dated 24.07.2024
1.3	The amount allocated for EMP and AEA activities shall be maintained in a separate bank account by the project proponent. The project proponent shall submit periodic audited financial reports and outcomes achieved by utilization of funds reserved for implementation of EMP and AEA activities

7.4	The Project Proponent shall develop a green belt with native tree species (having canopy type structure and especially trees, and not grass) before the completion of the project. The greenbelt
