

Request for adjournment has been received through E-mail from counsel for appellants.

This case has been pending before us since 27.02.2023 and no serious attempt has been made by the appellants to argue the matter. At one stage we noticed the default in appearance and dismissed the case for want of prosecution on 17.04.2023, thereafter an application for setting aside our Order dated 17.04.2023 was moved which was accepted and while restoring the main appeal to its original number we directed it to be listed on 25.09.2023. On that date none appeared and we adjourned the proceedings to 16.10.2023 and then there was another default in appearance. We still granted another opportunity and adjourned the matter to 06.11.2023. Mr. Parnav Goyal, Advocate appeared for Mr. Himanshu Raj and sought time to argue the matter. The proceedings were thus, adjourned to 20.11.2023 and another request was made by Mr. Parnav Goyal to adjourn the proceedings which we accepted and adjourned the matter to 08.01.2024. Again, request was made on 08.01.2024 and we listed

the matter for hearing to 12.02.2024 on which date Ms. Sapna Randhawa appeared to seek adjournment on the ground that arguing counsel was not well. This prayer was also accepted and we adjourned the proceedings to 21.03.2024.

Today, when the case was called out there was no representation.

Looking at the facts as noticed above we deem it appropriate to give a quietous to the matter and dismiss the appeal for want of prosecution.
