## Order u/s. 31 of Real Estate (Regulation & Development) Act, 2016 read with Rule 36 of Pb. State Real Estate (Regulation & Development) Rules, 2017.

When the matter was taken up, Ld. Counsel for the complainant requested to withdraw the present complaint with liberty to file afresh with better particulars, if required. However, before proceeding further, it is pertinent to note here that notice to respondents were issued in this matter and it was taken-up from time to time. Further, vide order dated 21.01.2025 following orders were passed:-

"Present:

Ms.R.K. Grewal, Advocate for the complainant. Sh. Vipul Monga, Advocate for Respondents no. 1, 5 & 6. None for respondents no. 2, 3, 4, and 7.

The reply of respondent no. 7 is already on record.

When the matter was taken up for hearing, the Ld. Counsel representing respondents no. 1, 5, and 6 brought to the attention of this Bench that these respondents have no connection or involvement in the present



matter. Instead, it was submitted that Royale Empire is the main promoter and should be impleaded as a respondent in this case. The Ld. Counsel for respondents no. 1, 5, and 6 further requested that their names be dropped from the array of respondents. This request was met with no objection from the Ld. Counsel for the complainant, who consented to their removal from the proceedings. In view of the same, respondents no. 1, 5, and 6 are hereby dropped from the proceedings.

Additionally, the Ld. Counsel for the complainant requested a short adjournment to file an application for impleading Royale Empire as a respondent in the matter. It is further noted that respondents no. 2, 3, and 4 have not appeared in today's proceedings. Their continued absence will be considered on the next hearing, once the application for impleadment will be received from the complainant's counsel.

To come up on **04.02.2025** @ **10.30** a.m. for filing of application."

Subsequent to 21.01.2025 the present matter was pending for amendment of the complainant. However, as per request of the complainant for withdrawal of the present complaint with liberty to file afresh, the complaint is dismissed as withdrawn with liberty to file afresh, if required by the complainant.

It is clarified that this dismissal is solely on account of the reported withdrawal and is without prejudice to the merits of the case. The file be consigned to the record room.
