When the matter was taken up, no one was present for the complainant. Perusal of the file reveals that the complaint was filed on 22.05.2023 and in response on 17.07.2023, Sh. Ankush Gupta son of Late Sh. Balabax Gupta attended the proceedings whereby it was asked to provide Succession-in-Certificate/Survivor's Certificate or any other government proof in his favour as Legal Heir and it was adjourned to 11.09.2023. But from 11.09.2023, the complainant is not appearing before this Authority vide interim orders dated 11.09.2023; 23.11.2023; 11.01.2024; 29.02.2024; 06.06.2024; 19.09.2024; 19.11.2024. The proceedings were conducted from time to time. Sufficient opportunities had already been given to the complainant and it appears that the complainant does not wish to pursue its matter further. In view the above, the present matter is dismissed in default with liberty to file afresh, if wishes to do so. File be consigned to record room.
