## Order u/s. 31 of Real Estate (Regulation & Development) Act, 2016 read with Rule 36 of Pb. State Real Estate (Regulation & Development) Rules, 2017.

When the matter was taken up for hearing today, the learned counsel for the respondent submitted that the complainant had sought exemption from PLC on the ground that the 11-foot road, being part of the 60-foot revenue road, should not attract PLC charges, and further stated that the respondent has agreed not to charge PLC from the complainant. Accordingly, he requested that the matter be disposed of, as the relief sought by the complainant has been accepted by the respondent, to which the complainant also consented.

In view of the above, the present complaint is disposed of in terms of the statement made by the respondent. It is clarified that this disposal is without prejudice to the merits of the case. The file be consigned to the record room.
